PUBLIC INFORMATION ADVISORY

WHAT: Richmond City Council will hold a special meeting for the introduction and expedited consideration of a resolution to declare vigorous support for and urge the General Assembly promptly to approve amendments recommended by the Governor to legislation legalizing the simple possession of up to one ounce of marijuana that are intended to promote equity for Richmond residents and other Virginia citizens disproportionately affected by the enforcement of laws prohibiting marijuana possession.

*The regularly scheduled **Organizational Development Standing Committee** meeting, scheduled for the same date and time, will take place at the conclusion of the special meeting.

WHERE: **This meeting will be held through electronic communication means pursuant to and in compliance with Ordinance No. 2020-093, adopted April 9, 2020, as most recently amended by Ordinance No. 2020-232, adopted December 14, 2020.** This meeting will be accessible through electronic communication means by the public and closed to in-person access by the public. Less than a quorum of the Organizational Development Standing Committee will assemble for this meeting in the Council Chamber on the 2nd floor of City Hall at 900 East Broad Street in Richmond, Virginia 23219, and most committee members and other staff will participate by teleconference/videoconference via Microsoft Teams.
